

Deloris Alexander, PhD, a Tenured Professor with Triple Faculty Appointments in the College of Agriculture, Environment and Nutrition Sciences (CAENS), the College of Arts and Sciences (CAS), and the College of Veterinary Medicine (CVM) Tuskegee University



Dr. Deloris is a native of Tuskegee, AL and holds degrees from Alabama State University (BS in Biology; minor in chemistry), Tuskegee University (MS in Environmental Science), Meharry Medical College (PhD in Biomedical Sciences), and post-doctoral experience from the University of North Carolina at Chapel Hill (Cancer Genetics, Host immunity). She is also certified as a Bioethics Trainer (NIH). Most recently, Dr. Alexander has been leading the Community Engagement subcommittee of TU's Community Health Task Force in response to the COVID-19 Pandemic. She is also one of three PI's of the Alabama Department of Public Health COVID Vaccination and Education Grant to TU.

Since arriving at TU as faculty in 2005, Dr. Alexander has been intimately involved in the launching of Tuskegee's PhD Program in Integrative Biosciences (IBS), which seeks to address the lack of well-trained, graduate-level, U.S. scientists. The IBS PhD program has provided a mechanism for fostering a more intensive biomedical research and training atmosphere and has produced more than 47 PhD holders and supported an equal number of MS degree graduates in the past 10 years. Dr. Alexander has many research interests, all related to infectious diseases. She is an avid researcher who has mentored more than 190 undergraduate and graduate students from various disciplines. In 2015 and 2016 she was recognized as a White House Champion of Change by the White House Initiatives for HBCUs Office. She currently uses her lab to understand how natural products might prove beneficial in the fight against diseases. Dr. Alexander, who served as the Deputy Director for Research for Tuskegee University's Health Disparities Institute for Research and Education, has been actively involved in research that seeks to reduce health disparities in the Alabama Black Belt Counties.

Moreover, Dr. Alexander has been a member of numerous grant proposal writing teams, which have coordinately been awarded millions of dollars from the Howard Hughes Medical Institute, the National Institutes of Health, the USDA/NIFA, and the National Science Foundation. These awards have supported the education and research of hundreds of high school, undergraduate, and graduate students. Dr. Alexander is teaches more than a dozen courses each year, including bioethics, parasitology, epidemiology, molecular biology and environmental health sciences. She has been a reviewer for NSF, HHMI, NOAA, the USDA and several book publishers. She is also a member of the American Society for Microbiology (ASM), the American Association for Cancer Research (AACR), the National Environmental Health Association (NEHA), and Sigma Xi. She also sings, writes short stories, assembles genealogies for African-American families and, occasionally, takes a day off to enjoy a good clearance sale. She is a native of Tuskegee, AL and is a product of the Tuskegee Public School System.


